The Brovary City Territorial Community (*Ukrainian: "hromada"*) was established on **9** February 2021 within the decentralisation reform.



Transport connection

External transport links of the community are provided by two types of transport: rail and road.

The neighborhood with the city of Kyiv ensures direct access to international highways towards the EU countries, as well as the ports on the Black Sea and the Danube river Okraine's northern border



Housing & public utilities

The public utilities provide a full range of services for communal life.

- □ In the city of Brovary, multi-apartment residential buildings are covered by a **network of centralised heat supply.**
- Production and supply of thermal energy for multi-apartment buildings are mainly carried out by the communal enterprise <u>Brovaryteplovodoenergia</u>.
- Private households have individual heat sources, while industrial enterprises are mostly equipped with their own boilers.
- Gas and power supply in the community is centralised.
- □ The **main source of water supply** is the Desna River. The total length of watercourses is over 260 km.
- Water supply and sewerage services are provided by a utility company "Brovaryteplovodoenergia" that monitors the quality of water before and after purification in its own chemical and bacteriological laboratory.
- □ **Collection and removal of household waste** in the community is mainly carried out by LLC CELTIC TBO, which is made in a separate (glass, paper, plastic) and mixed way.
- Currently, the Brovary City Territorial Community develops a scheme for sanitary cleaning of the community's localities settlements. To improve the environmental situation, 28 spontaneous landfills were eliminated in 2023.

Sustainable energy development

The city of Brovary is a supporter of **Covenant of Mayors**, a European initiative aimed at improving energy use efficiency.

- □ The automated energy monitoring system "Kyiv Region Energy Efficient" was installed in 76 budgetary institutions.
- □ There are 4 stations of the automated air monitoring system operating in the industrial and residential areas.
- □ The community is installing solar panels as an alternative energy source. In particular, the total nominal capacity of the solar power plant installed at Kievguma LLC, one of the city's leading industrial enterprises, is 671 kW. This will allow generating ~ 600 thousand kW per year, which will cover almost a tenth of the company's needs.
- □ In addition, electric cars (EVs) can be charged at 15 stations in the city of Brovary.

Sustainable energy development

In order to attract investments, loans and grants for energy efficiency measures at municipal facilities, Brovary has launched the project "Modernisation of the outdoor lighting system" as part of its participation in the Energy Saving Programme of the Nordic Environment Finance Corporation (NEFCO).

The communal enterprise"Brovaryteplovodoenergia" is a participant in the Sweden-Ukraine District Heating Support Programme (SUDH) with the aim of improving the environmental situation in Brovary.

The project implementation results are expected to be the following:

- Reduced usage of waste heat, as well as installation of new equipment, will lead to significant gas and electricity savings.
- Social benefits include enhanced improving the quality and reliability of the centralised heating services and hot water supply for nearly 60 thousand consumers of centralised district heat supply in Brovary.

- □ The city of Brovary is the largest territorial unit within the community, where more than 90% of the population is concentrated.
- □ As of the end of 2021, the share of the economically active population significantly exceeded other age categories.
- □ In the **gender structure**, there are 12 females for every 10 males.
- After the military aggression started, part of the community's permanent population left for other regions of Ukraine and abroad, which was set off by an influx of people from other parts of the country.



Available labour resources & employment

A characteristic feature of the community is **"pendulum migration"** - regular commuting of more than 30% of the economically active population to Kyiv and back.

The community's **average registered number of full-time employees** corresponds to approximately one third of the entire economically active population of Brovary.





POPULATION & LABOUR

Labour market

Since the beginning of the full-scale invasion, the community has faced an outflow of active working-age population from its labour market, including qualified personnel.

The outflow of workers has been directed, in particular, to the ranks of the Armed Forces of Ukraine, abroad (mostly working - age women), to volunteer organisations, etc.

At the same time, the **Brovary City and District Employment Centre provides labour resources to the community's labour market.**



The community social policy is based upon the **principles of mutual respect, equality, social protection and spiritual development.**

INCLUSIVENESS & SOCIAL PROTECTION

- As of September 2023, 22 408 children (of whom, 1 667 with special educational needs and 4 577 of IDPs) were registered in the Brovary community.
- □ The community is implementing the programme of support for young families and youth development "Youth in Action" for 2022-2026.
- □ In December 2022, a **modular town** for 352 IDPs was built at the expense of Polska pomoc. The temporary housing is equipped with all necessary furniture, sanitary, and kitchen appliances and utensils at the cost of the local budget and philanthropists. Accommodation and meals in this town are free of charge.

- □ The **Municipal Centre for Comprehensive Rehabilitation provides** 234 disabled children with medical, psychological, pedagogical, social and physical support, as well as professional rehabilitation.
- 3,258 elderly and disabled people attend the Brovary City Territorial Centre for Social Services where they receive vital services on a regular basis. The centre provides 80 lonely people with lunches daily, gives free hairdressing services to 20 people a day, etc. The institution has an inpatient care unit for permanent or temporary residence of 10 single people.

- □ In general, nearly 25% of the community residents are engaged in sports.
- Inhabitants of Brovary spend their free time in public gardens and parks. In the city of Brovary, there is a number of alleys, squares, and other green areas. The community has 4 parks with a total area of 44 hectares (the largest of them: Park of Culture and Recreation, Pryozernyi Park, Taras Shevchenko Park, 5 public gardens with a total area of 4 hectares, and 4 recreation areas.

Medical facilities

Residents of the community obtain a full range of high-quality medical services in the **communal non-profit institutions**:



Command and staff trainings are conducted to eliminate the consequences of emergencies in case of accidents at high-risk facilities.

- □ The residents of Brovary are asked to make the reserve of water, food, and essential items, and, in case of an air raid alert, immediately go to temporary shelters.
- □ Trade facilities and household service establishments meet the people requirements.
- □ Local businesses work to support the economy of the community, as well as of the entire country.


The leading branch of the community economy is industry.

- The industrial complex is based on processing enterprises.
- Major types of products are rubber and plastics, finished metals, textiles, food and engineering products.

Other important components are **agriculture and residential construction**.

- 4 business entities operate in Knyazhychi and Trebukhiv, with crop production as a priority.
- Winter rye, winter wheat, winter rapeseed, corn and sunflower are grown on the community agricultural lands.
- Housing construction is boosted by the proximity and easy access to Kyiv, combined with the relatively low cost for purchase of a housing.







Investment proposals

RECONSTRUCTION OF "ZIROCHKA" PRESCHOOL EDUCATION INSTITUTION

Location: 3 Yaroslava Mudroho Str., the city of Brovary

Description

The project envisages construction of a separate building for two children centres, as well as a block of medical and technical premises, with the demolition of the existing structures and buildings located on the site of the children's institution.

The project is being implemented under the Ukraine Recovery Emergency Credit Programme with funding from the European Investment Bank.

Goal and expected results

After reconstruction, 3 nursery and 3 pre-school groups will accommodate up to 105 children, who will spend their time at:

- □ Playgrounds that are placed close to the buildings, separated by ageappropriate sidewalks, have standardised areas of coverings and sheds.
- □ A sports and playground with a 30-meter running track
- A playground for young naturalists

CONSTRUCTION OF A FIRST-GRADE SCHOOL

Location: 17 B Symona Petliury Str. , the city of Brovary

Description

Construction of a 3-storey comprehensive school, designed for 960 students (32 classes), with a total area of more than 15 thousand m², is in the process of the implementation.

Goal and expected results

- Reducing social tension in one of the neighbourhoods of Brovary
- Ensuring equal access to education for a first-grade school pupils in one shift
- □ The school building includes classrooms, sports and gymnasiums, assembly and multipurpose halls; a dance studio, canteen, library, medical centre and administrative premises.

CONSTRUCTION OF VASYLIA SYMONENKA STREET IN BROVARY

Location: a site between Kyivska and Olhy Kobylianskoi Str., the city of Brovary

Description


The project envisages the construction of a 4-lane carriageway with safety lanes, a two-way sidewalk, a bicycle lane, dividing lanes, and a variable width lawn.

All pedestrian crossings are equipped with safety islands and a lowered kerb. In the future, one of the intersections will be equipped with traffic lights.

After completion of the construction, public transport is planned to move along the street.

Goal and expected results

Improving comfort and safety of road traffic.

CAPITAL REPAIR OF THE ROAD LINE THROUGH THE RAILWAY TRACK ON ONIKIENKA OLEHA STREET IN THE CITY OF BROVARY, KYIV REGION

Location: Oleha Onikienka Street in Brovary, Kyiv region

Description:

The overpass over the railway track will have the following characteristics after the overhaul:

- road category main street of district significance
 length of the overpass–178,14 m;
- roadway of the overpass will have 2 lanes in one direction and 2 in the opposite direction;
- Two elevated sidewalks for combined cyclists and pedestrians were arranged, separated from the carriageway by barrier fencing, and galvanised railings were placed along the front edges of the sidewalks.

Goal and expected results:

To ensure the reliability of the bridge deck piers and traffic safety on the overpass.



Investment proposals

RECONSTRUCTION OF A PART OF A BUILDING WITH EXTENSION OF A RECREATIONAL POOL

Location: 8A Heroiv Ukrainy Str., the city of Brovary

Description

The main project solutions include extension of a 2-storey facility to one of the existing blocks of the centre, with the placement of a recreational pool with auxiliary and technical facilities for 10 children to attend at the same time.

Goal and expected results

According to the project, there are two swimming basins in the building: one having dimensions of 11x3.4 m and 0.8-1.25 m deep, and the other one having dimensions of 3x2.75 m and 0.6 m deep.

The terms of reference for the development of a working project for heat supply, hot water supply, heating and maintenance of the water temperature in the facility's swimming pool envisages the installation of Dimplex air-to-water heat pumps, a solar system and additional electrical heat sources.

RECONSTRUCTION OF THE INFECTIOUS DESEASE DEPARTMENT OF THE CHILDREN'S CLINIC OF BROVARY MULTIDISCIPLINARY CLINICAL HOSPITAL

Location: 47 Yaroslava Mudroho (Kirova) Str, the city of Brovary

Description

The reconstruction was caused by the emergency state of the building structures. The infectious Disease Department of the Children's hospital is a basic facility for providing medical care to young patients with particularly dangerous diseases for the residents of Brovary district.

Strengthening of the building's supporting structures, reconfiguration of the roof and partial replacement of utilities: water supply and sewage systems, electricity and heating systems; installation of a mechanical pressure supply and exhaust ventilation system, air conditioning system, and oxygen supply system with backup capabilities.

Goal and expected results

After implementation of the project, the department will continue providing medical care to small patients, having particularly dangerous diseases, from Brovary and its surroundings.

The project capacity is 60 beds.

RECONSTRUCTION OF AN ADMINISTRATIVE BUILDING OF THE CITY EXECUTIVE COMMITTEE WITH ARRANGEMENT OF AN AUDITORIUM, AS WELL AS OF A CULTURAL AND EXHIBITION COMPLEX

Location: 18 Heroiv Ukrainy Str., the city of Brovary

Description

The reconstruction project of the cultural centre envisages a number of measures to simplify access to the facility for people with limited mobility.

It is planned to redesign the first floor toilets with the installation of additional cubicles for people with special needs. To provide access for visitors of this category to the second and third floors, the project envisages the construction of an elevator shaft equipped with two elevators of appropriate sizes. The new cultural centre with a large auditorium will make it possible to hold better and larger events and rent it out for excursions, exhibitions, conferences, etc.

Goal and expected results

To create favourable conditions for holding cultural events aimed at personality development.

The project capacity is 448 seats.

CONSTRUCTION OF A COMPLEX OF I-III GRADES SCHOOLS

Location: 103 Vasylia Symonenka Str., city of Brovary

Description

To solve the problem of providing equal and accessible education in the 5th micro district of the IV residential district, the master plan provides for the construction of schools of the first grade for 840 pupils and of the second and third grades for 1500 pupils.

Two separate four- storey buildings with basement and upper technical floors, 78 classrooms.

Each building has a dining hall, gymnasiums and universal sports halls, dentists' offices, physiotherapy, therapeutic and treatment rooms.

All premises are linked by corridors and recreation areas.

The needs of people with disabilities such as ramps on the porches of the building entrances, universal cabins in the toilets and lifts are taken into account.

A separate entrance, a wardrobe, toilets and sleeping rooms are provided for the first classes.

RECONSTRUCTION OF SEWAGE TREATMENT FACILITIES LOCATED IN KRASYLIVKA VILLAGE COUNCIL IN BROVARY DISTRICT, KYIV REGION, WITH AN INCREASE IN CAPACITY FROM 22,000 M3 PER DAY TO 31,000 M3 PER DAY

Location: within the boundaries of the Kalynivska amalgamated territorial community

Description:

Year of construction 1978 - 1980.

Equipment has been used for over 40 years

Actual capacity - 22.4 thousand m3/day.

Annual sludge production - 2 thousand tonnes per year

An investment feasibility study was developed In 2021.
